

**FRUITLAND PARK SPECIAL CITY COMMISSION MEETING MINUTES**

MEETING STATISTICS. A special meeting of the Fruitland Park City Commission was conducted in the Commission Chambers of City Hall, 506 West Berckman Street, Fruitland Park, Florida on Thursday, February 21, 2013 beginning at 6:00 p.m

INVOCATION AND PLEDGE OF ALLEGIANCE. Mayor Bell delivered the invocation followed by the Pledge of Allegiance led by Vice Mayor Kelly.

ROLL CALL. Mayor Bell asked City Clerk Diane Gibson Smith to call the roll.

ELECTED OFFICIALS PRESENT. Commissioner Albert O. Goldberg, Commissioner Christopher Cheshire, Commissioner John L. Gunter, Jr., Vice Mayor Sharon Kelly, and Mayor Christopher J. Bell.

MUNICIPAL OFFICIALS/OTHERS PRESENT. Interim City Manager (ICM) Stephen Cottrell, Police Chief (PC) Terry Isaacs, City Clerk (CC) Diane Gibson Smith.

01. Mayor Bell announced the Shade meeting which would have the following members present: Vice Mayor Kelly, Commission Goldberg, Interim City Manager Cottrell, Commissioner Cheshire, Commissioner Goldberg, Mayor Bell, City Attorney Scott Gerken, and a court reporter. The estimated time is approximately 30 minutes.


By consensus, the letter will not be sent.

Commissioner Goldberg noted the pot will be stirred for a bit by this person and then nothing will be written for a while.


03. MAYOR BELL'S COMMENTS. Mayor Bell asked if everyone had had a chance to sit down with the Interim City Manager.
